- 2 § 7201. Scope of chapter.
- 3 This chapter relates to counterterrorism planning,
- 4 preparedness and response.
- 5 § 7202. Definitions.
- 6 The following words and phrases when used in this chapter
- 7 shall have the meanings given to them in this section unless the
- 8 context clearly indicates otherwise:
- 9 <u>"Disaster medical assistance team." A complement of</u>
- 10 individuals organized in accordance with standards developed by
- 11 the agency and applicable Federal agencies to provide medical
- 12 <u>service at the scene of disasters and mass casualty incidents.</u>
- "Disaster mortuary response team." A complement of
- 14 individuals organized in accordance with standards developed by
- 15 the agency and applicable Federal agencies to provide mortuary
- 16 service at the scene of disasters and mass casualty incidents.
- 17 "FEMA." The Federal Emergency Management Agency.
- 18 <u>"Letter of agreement." A written agreement between a</u>
- 19 regional counterterrorism task force and a public, semipublic,
- 20 private or nonprofit corporation, business, association,
- 21 partnership, authority, individual or other entity that provides
- 22 for:
- 23 (1) Personnel, equipment, supplies, training facilities
- or other resources either directly to or in support of the
- 25 <u>task force's specialized regional counterterrorism response</u>
- 26 team.
- 27 (2) Workers' compensation and death benefits.
- 28 (3) Use of county 911 communications centers, county
- 29 emergency management agencies or the State emergency
- 30 operations center.

- 1 (4) Member participation in training exercises, drills
- 2 <u>and actual activation and deployment.</u>
- 3 "Municipal" or "municipality." A city, borough, incorporated
- 4 town, township or home rule municipality of this Commonwealth.
- 5 "Mutual aid." A county's, municipality's or volunteer
- 6 service organization's affirmative act of sending its personnel,
- 7 equipment or resources to the scene of an actual or potential
- 8 <u>disaster</u>, whether inside or outside the boundaries of this
- 9 <u>Commonwealth, in response to an official dispatch request from a</u>
- 10 county 911 communications center, county emergency management
- 11 agency or the State emergency operations center.
- 12 <u>"Mutual aid agreement." A written agreement between a</u>
- 13 regional counterterrorism task force and a county, municipality
- 14 or volunteer service organization that provides for:
- 15 (1) The county, municipality or volunteer service
- organization to provide personnel, equipment or other
- 17 resources in response to an actual or potential disaster.
- 18 (2) Workers' compensation and death benefits.
- 19 (3) Use of county 911 communications centers, county
- 20 emergency management agencies or the State emergency
- 21 operations center.
- 22 (4) Member participation in training exercises, drills
- and actual activation and deployment.
- 24 "NIMS." The National Incident Management System.
- 25 "Regional counterterrorism task force." A complement of
- 26 Federal, State, county and municipal emergency management,
- 27 health, law enforcement, public safety and other officials and
- 28 representatives from volunteer service organizations, private
- 29 business and industry, hospitals and medical care facilities and
- 30 other entities within a multicounty area as determined by the

- 1 agency that is responsible for conducting counterterrorism
- 2 planning, training preparedness and response activities.
- 3 "Specialized regional counterterrorism response team." As
- 4 <u>follows:</u>
- 5 (1) A complement of individuals established by a
- 6 regional counterterrorism task force and organized in
- 7 <u>accordance with standards developed by the agency and</u>
- 8 <u>applicable Federal agencies to respond to emergencies</u>
- 9 <u>involving an actual or potential disaster.</u>
- 10 (2) The term includes a disaster medical assistance team
- 11 <u>and disaster mortuary response team.</u>
- "Specialized Statewide response team." As follows:
- 13 (1) A complement of individuals organized by the
- 14 Commonwealth to provide specialized personnel, equipment and
- other support capabilities in response to an actual or
- 16 <u>potential disaster in this Commonwealth.</u>
- 17 (2) The term includes a disaster medical assistance team
- and disaster mortuary response team.
- 19 "Urban search and rescue task force." A multidisciplined
- 20 complement of individuals organized by the agency in accordance
- 21 with standards developed by the agency and FEMA to provide
- 22 emergency response and search and rescue capabilities and
- 23 <u>resources at the scene of a disaster consistent with NIMS</u>
- 24 guidelines.
- 25 "Volunteer service organization." A volunteer fire company,
- 26 volunteer ambulance or medical company, volunteer rescue squad
- 27 or any other volunteer entity organized and chartered or
- 28 incorporated in this Commonwealth or chartered by the Congress
- 29 of the United States for the primary purpose of providing
- 30 emergency services as defined in section 7102 (relating to

- 1 definitions).

- 14 § 7211. Counterterrorism planning, preparedness and response
- program.
- 16 (a) Coordination and consultation. -- The agency shall
- 17 coordinate and consult with other State agencies, departments
- 18 and offices, including the Office of Homeland Security of the
- 19 Commonwealth, to establish, develop and maintain a
- 20 counterterrorism planning, preparedness and response program to
- 21 promote and protect the health, safety and welfare of emergency
- 22 responders, public officials and the general public from actual
- 23 <u>or potential disasters in this Commonwealth.</u>
- 24 (b) Agency responsibilities. -- The agency shall:
- 25 (1) Define the necessary components and composition of
- 26 <u>regional counterterrorism task forces and specialized</u>
- 27 <u>regional counterterrorism response teams and the respective</u>
- 28 regional counterterrorism zones for each, but shall not be
- 29 responsible for appointing individual members to the regional
- 30 counterterrorism task forces or the specialized regional

- 1 counterterrorism response teams.
- 2 (2) Provide training and technical assistance for
- 3 counterterrorism planning, preparedness and response.
- 4 (3) Establish guidelines and policies to coordinate
- 5 emergency response activities with Federal, State, county and
- 6 <u>municipal emergency management, health, law enforcement,</u>
- 7 <u>public safety and other officials and representatives from</u>
- 8 <u>volunteer service organizations, private business and</u>
- 9 <u>industry</u>, hospitals and medical care facilities and other
- 10 <u>entities responsible for the health, safety and welfare of</u>
- 11 <u>the residents of this Commonwealth. The agency shall consult</u>
- 12 <u>with representatives of the regional counterterrorism task</u>
- forces to develop such policies and guidelines necessary to
- 14 <u>carry out this chapter.</u>
- 15 (4) Require the regional counterterrorism task forces to
- 16 <u>prepare counterterrorism emergency response plans or</u>
- 17 protocols, readiness evaluation reports or other documents
- deemed necessary by the agency.
- 19 (5) Provide grants and other funding assistance as
- 20 required by this chapter.
- 21 (6) Conduct terrorist incident exercises.
- 22 (7) Provide technical assistance to regional
- 23 counterterrorism task forces in developing and entering into
- 24 mutual aid agreements and letters of agreement.
- 25 (8) Establish a certification program for specialized
- 26 regional counterterrorism response teams that may include
- 27 <u>standards for the administration, composition, training and</u>
- 28 equipping of the teams.
- 29 § 7212. Regional counterterrorism task forces.
- 30 (a) Establishment. -- The agency, in coordination with State,

- 1 county and municipal emergency management, health, law
- 2 <u>enforcement</u>, <u>public safety and other officials and</u>
- 3 representatives from volunteer service organizations, private
- 4 <u>business and industry</u>, <u>hospitals and medical care facilities and</u>
- 5 other entities responsible for the health, safety and welfare of
- 6 the residents of this Commonwealth, shall establish regional
- 7 <u>counterterrorism task forces throughout this Commonwealth.</u>
- 8 (b) Response plans. -- A regional counterterrorism task force
- 9 <u>shall prepare a counterterrorism preparedness and response plan</u>
- 10 in accordance with guidelines developed by the agency. The
- 11 agency shall review and approve each plan in a timely manner,
- 12 but no later than 90 days after its submission to the agency.
- 13 The task force shall review and update the plan on an annual
- 14 basis.
- 15 <u>(c) Meetings.--Regional counterterrorism task force meetings</u>
- 16 that are called to discuss sensitive or classified law
- 17 enforcement, terrorist threat assessment or other confidential
- 18 public and private facility safety information shall not be
- 19 deemed a public record subject to disclosure under 65 Pa.C.S.
- 20 Ch. 7 (relating to open meetings).
- 21 § 7213. Regional counterterrorism response and preparedness.
- 22 (a) Specialized regional counterterrorism response teams. -- A
- 23 regional counterterrorism task force shall establish specialized
- 24 regional counterterrorism response teams.
- 25 (b) Regional counterterrorism response zones. -- The agency
- 26 shall establish primary and secondary regional response zones
- 27 within this Commonwealth for specialized regional
- 28 <u>counterterrorism response teams. The regional response zones may</u>
- 29 consist of multiple counties or portions of several adjoining
- 30 counties as determined by the agency.

- 1 (c) Activation and deployment. -- A specialized regional
- 2 counterterrorism response team may be activated and deployed
- 3 inside or outside this Commonwealth by the Governor, the
- 4 Governor's designee or an official designated by the appropriate
- 5 <u>regional counterterrorism task force.</u>
- 6 § 7214. Urban search and rescue task forces.
- 7 (a) Establishment. -- The agency shall establish urban search
- 8 and rescue task forces, including:
- 9 (1) At least one urban search and rescue task force
- organized by the Commonwealth within a regional
- 11 <u>counterterrorism task force covering a county of the first</u>
- 12 class that meets or exceeds the minimum requirements of a
- 13 Type 1 urban search and rescue task force as designated by
- 14 <u>FEMA in the NIMS guidelines.</u>
- 15 (2) At least one urban search and rescue task force
- organized by the Commonwealth within a regional
- 17 counterterrorism task force covering a county of the second
- 18 class, which shall be called Pennsylvania Task Force 2 (PA-
- 19 TF2) and, no later than January 1, 2026, shall meet or exceed
- the minimum requirements of a Type 3 urban search and rescue
- 21 task force as designated by FEMA in the NIMS guidelines, as
- 22 <u>certified by the agency.</u>
- 23 (b) Support.--The task forces shall also provide
- 24 professional, logistical, material and other forms of support to
- 25 regional counterterrorism task forces and specialized regional
- 26 <u>counterterrorism response teams</u>.
- 27 (c) Organization. -- An urban search and rescue task force
- 28 shall be organized in accordance with guidelines developed by
- 29 the agency in coordination with FEMA and members of the task
- 30 force.

- 1 (d) Responsibilities. -- An urban search and rescue task force
- 2 <u>shall respond to actual or potential disasters in this</u>
- 3 Commonwealth and shall also perform search and rescue functions
- 4 <u>as delineated in The Robert T. Stafford Disaster Relief and</u>
- 5 Emergency Assistance Act (Public Law 93-288, 42 U.S.C. § 5121 et
- 6 <u>seq.), the Federal Response Plan or its successor, Emergency</u>
- 7 <u>Management Assistance Compact missions under Chapter 76</u>
- 8 (relating to Emergency Management Assistance Compact), as
- 9 requested, and the counterterrorism preparedness and response
- 10 plans created in accordance with this chapter.
- 11 (e) Activation and deployment. --
- 12 (1) An urban search and rescue task force or any of its
- components, subgroups or regional elements may only be
- 14 activated and deployed to the scene of a disaster by either:
- 15 (i) the Governor or the Governor's designee; or
- 16 <u>(ii) the President of the United States or a FEMA-</u>
- 17 designated official.
- 18 (2) During an activation and deployment by the Governor,
- 19 the administrative and operational costs of the task force,
- 20 its individual members and their employers, State agencies
- and other parties shall be paid under the Governor's
- 22 declaration of disaster emergency, including paying or
- reimbursing any parties for workers' compensation and death
- 24 benefits in the event of injury or death of an urban search
- and rescue task force member.
- 26 (f) Workers' compensation and death benefits. -- A member of
- 27 <u>an urban search and rescue task force shall be eligible to</u>
- 28 receive workers' compensation and death benefits in the event of
- 29 injury or death that occurs during the period of activation or
- 30 deployment.

- 1 (q) Funding, grants and donations. -- In addition to money
- 2 that is provided to a task force under section 7216 (relating to
- 3 grant program) or the authority of section 1508 of the act of
- 4 April 9, 1929 (P.L.343, No.176), known as The Fiscal Code, the
- 5 <u>urban search and rescue task force may be eliqible to receive</u>
- 6 grants, donations of equipment and supplies and other funds from
- 7 any source. As an agent of the Commonwealth, an urban search and
- 8 <u>rescue task force or regional counterterrorism task force is</u>
- 9 <u>entitled to tax-exempt status from the Federal Government.</u>
- 10 § 7215. Specialized Statewide response teams.
- 11 <u>(a) Establishment.--The Commonwealth may establish one or</u>
- 12 more specialized Statewide response teams. These specialized
- 13 <u>statewide response teams shall also provide professional</u>,
- 14 <u>logistical</u>, material and other forms of support to the regional
- 15 <u>counterterrorism task forces and specialized regional</u>
- 16 <u>counterterrorism response teams organized in this Commonwealth.</u>
- 17 The Commonwealth may enter into an agreement with a One Call
- 18 System as defined in the act of December 10, 1974 (P.L.852,
- 19 No.287), referred to as the Underground Utility Line Protection
- 20 Law, for the provision of specialized communications services.
- 21 (b) Organization and responsibilities. -- Specialized
- 22 Statewide response teams shall be organized in accordance with
- 23 <u>guidelines developed by the Commonwealth in consultation with</u>
- 24 applicable Federal or State agencies.
- 25 (c) Activation. -- Specialized Statewide response teams may
- 26 only be activated and deployed to the scene of a disaster by the
- 27 Governor, the Governor's designee or an official designated by
- 28 the appropriate regional counterterrorism task force.
- 29 <u>§ 7216. Grant program.</u>
- 30 (a) Authorization. -- The agency may make grants to regional

- 1 <u>counterterrorism task forces</u>, <u>specialized regional</u>
- 2 <u>counterterrorism response teams</u>, <u>specialized Statewide response</u>
- 3 teams and urban search and rescue task forces to assist them in
- 4 carrying out this chapter, including entering into letters of
- 5 agreement or mutual aid agreements or providing mutual aid.
- 6 (b) Grants and funding. -- Regional counterterrorism task
- 7 <u>forces, specialized regional counterterrorism response teams,</u>
- 8 specialized Statewide response teams and urban search and rescue
- 9 task forces may receive grants and funding from the Federal
- 10 Government and the Commonwealth through application to the
- 11 agency or other entity providing grants or funding for the
- 12 purposes of this chapter.
- (c) Limitation.--Grants shall only be made by the agency to
- 14 the extent that funding is available.
- 15 § 7217. Miscellaneous provisions.
- 16 (a) Immunity from liability.--The provisions of 42 Pa.C.S. §
- 17 8331 (relating to medical good Samaritan civil immunity), 8332
- 18 (relating to emergency response provider and bystander good
- 19 Samaritan civil immunity) or 8332.4 (relating to volunteer-in-
- 20 public-service negligence standard) shall apply to a member of a
- 21 specialized regional counterterrorism response team, an urban
- 22 search and rescue task force or a specialized Statewide response
- 23 team and an individual who provides logistical, material or
- 24 other forms of emergency response support to a team or task
- 25 force during activation or deployment of a team or task force to
- 26 a potential or actual disaster or while engaged in a task force
- 27 <u>or team drill or training exercise.</u>
- 28 (b) Effect on workers' compensation premiums. -- Nothing in
- 29 this chapter shall be construed to permit an insurer to raise
- 30 workers' compensation premiums due to the participation or

- 1 membership of a county, municipality, volunteer service
- 2 <u>organization</u>, <u>individual or employer on a regional</u>
- 3 <u>counterterrorism task force</u>, <u>specialized regional</u>
- 4 <u>counterterrorism response team, specialized Statewide response</u>
- 5 team or urban search and rescue task force.
- 6 § 7218. Commonwealth indemnification.
- 7 The Commonwealth shall indemnify a county or municipality for
- 8 costs related to damaged county or municipal property that
- 9 <u>results from participation in a regional counterterrorism task</u>
- 10 force, specialized regional counterterrorism response team or
- 11 <u>specialized Statewide response team response only when all of</u>
- 12 the following conditions are met:
- 13 (1) The county or municipality is responding upon
- 14 <u>activation or deployment by the Governor.</u>
- 15 (2) The damage to county or municipal property occurs
- 16 <u>outside of the primary regional counterterrorism response</u>
- zone.
- 18 (3) The county's or municipality's insurance does not
- 19 cover the property damage.
- 20 (4) The property damage was not caused by the willful
- 21 misconduct of the county or municipality or any of its
- 22 employees or agents.
- 23 Section 2. Title 35 is amended by adding a section to read:
- 24 § 7605. Construction.
- 25 For purposes of Article VI of the compact, "officers or
- 26 employees of a party state" shall be construed to include urban
- 27 search and rescue task forces as defined in section 7202
- 28 <u>(relating to definitions) that are assets of the Federal</u>
- 29 <u>Emergency Management Agency or Pennsylvania Emergency Management</u>
- 30 Agency and the components, subgroups and regional elements of

- 1 the task forces based in this Commonwealth.
- 2 Section 3. Repeals are as follows:
- 3 (1) The General Assembly finds that the repeals under
- 4 paragraphs (2) and (3) are necessary to effectuate the
- 5 addition of 35 Pa.C.S. Ch. 72.
- 6 (2) The definitions, excluding the definitions of
- 7 "department" and "local health department," in section 102 of
- 8 the act of December 16, 2002 (P.L.1967, No.227), known as the
- 9 Counterterrorism Planning, Preparedness and Response Act, are
- 10 repealed.
- 11 (3) Chapter 2 of the Counterterrorism Planning,
- 12 Preparedness and Response Act, is repealed.
- 13 Section 4. The addition of 35 Pa.C.S. Ch. 72 is a
- 14 continuation of Chapter 2 of the act of December 16, 2002
- 15 (P.L.1967, No.227), known as the Counterterrorism Planning,
- 16 Preparedness and Response Act. The following apply:
- 17 (1) Except as otherwise provided in 35 Pa.C.S. Ch. 72,
- 18 all activities initiated under Chapter 2 of the
- 19 Counterterrorism Planning, Preparedness and Response Act,
- shall continue and remain in full force and effect and may be
- completed under 35 Pa.C.S. Ch. 72. Orders, regulations, rules
- 22 and decisions which were made under Chapter 2 of the
- 23 Counterterrorism Planning, Preparedness and Response Act and
- 24 which are in effect on the effective date of this section
- 25 shall remain in full force and effect until revoked, vacated
- or modified under 35 Pa.C.S. Ch. 72. Contracts, obligations
- 27 and collective bargaining agreements entered into under
- 28 Chapter 2 of the Counterterrorism Planning, Preparedness and
- 29 Response Act are not affected nor impaired by the repeal of
- 30 Chapter 2 of the Counterterrorism Planning, Preparedness and

- 1 Response Act.
- 2 (2) Except as specified in paragraph (3), any difference
- 3 in language between 35 Pa.C.S. Ch. 72 and Chapter 2 of the
- 4 Counterterrorism Planning, Preparedness and Response Act is
- 5 intended only to conform to the style of the Pennsylvania
- 6 Consolidated Statutes and is not intended to change or affect
- 7 the legislative intent, judicial construction or
- 8 administration and implementation of Chapter 2 of the
- 9 Counterterrorism Planning, Preparedness and Response Act.
- 10 (3) Paragraph (2) does not apply to the addition of the
- 11 following provisions:
- 12 (i) The definitions of "NIMS" and "urban search and
- rescue task force" in 35 Pa.C.S. § 7202.
- 14 (ii) 35 Pa.C.S. § 7212(b).
- 15 (iii) 35 Pa.C.S. \S 7214(a), (b), (d) and (g).
- 16 (iv) 35 Pa.C.S. § 7215(c).
- 17 Section 5. This act shall take effect in 60 days.
